#### **District Managers Report:**

#### **Operational Recommendations:**

• Tab 1: <u>Firepit:</u> Ratification of expenditures for repair of the firepit. [required due to vandalism] for \$1,500. (See Attached).

<u>Background:</u> There was some vandalism on the fire pit which prohibited it from working. We were able to get the damage cleared and had the gas company come in and revamp the firepit and make it safer to operate. The pit is fully functional, and meets are code requirements.

 Tab 2: Drainage Work on District Property Behind the Bluffs Community: (See Attached)

<u>Background:</u> The District Engineer has been onsite examining issues with drainage problems in the community. At the November Board meeting the Board approved going out for bids to make the necessary repairs. The District Attorney reviewed the RFP, and the Engineer is obtaining proposals from several vendors.

<u>Recommendation:</u> That the Board would authorize the Chairman, District Engineer, District Manager and District Attorney to authorize the Chairman to execute a proposal with the lowest responsive bidder (as long as it does not exceed \$48,000 dollars) to complete the drainage work.

Tab 3: Discussion of pond maintenance for ponds in the Summer Bay community: (See Attached)

<u>Background:</u> There has been an ongoing problem in the maintenance of several ponds in the Summer Bay area. They are hard to access and very had to maintain. In discussions with the Greenery (the District landscaper) They are looking for solutions that would better able them to access the ponds and keep them maintained.

Please see the pictures that correspond to each pond located in Summer Bay. The main issue across the ponds is a lack of an entrance and major washout. These are impossible to mow, and we have been using weedeaters and push mowers to keep these under control. What should take ½ day is now taking closer to 2-

2.5 days to cut all of these ponds. This will get much worse in the summer when the expectation is to cut these on a weekly basis. Too much time will be dedicated to these ponds and other areas in the community might be affected. A lot of it seems to be erosion from the lots down into the pond banks, on graded lots and completed lots.

Access to the ponds throughout Grand Oaks has been tricky since the start. There does not seem to be clear right of ways to enter the ponds for maintenance. Luckily, certain homeowners have allowed us access and we can make do, but it could create issues in the future if they change their minds or move.

**Recommendation:** Authorize the District Engineer and District Manager to work with the Greenery to provide alternatives to improve access to the ponds and bring recommendations back to the next Board meeting.

#### Tab 4: Required preserve maintenance work for upland buffers:

**Background:** The Water Management District sent a letter to the District in October outlining various actions that needed to be completed in order to bring the upland buffers into compliance with existing permits. Terracon was hired as an Environmental Consultant to develop proposals and recommendations for addressing the required remediation work required by the Water Management District.

The remediation work is required because upland buffer areas have been mowed, trees removed, signs removed, native plants removed, and other obstructions placed in the buffer areas.

The Water Management District required that letter be sent out to all landowners notifying them that the upland buffer areas are not be touched (in anyway) and be left in their nature state. The residents letters have been sent out. We included language that stipulates that if residents, landscapers and/or builders disturb the buffer areas (once the remediation is completed), they will be held responsible for the cost of any required remediation work in the future.

We have received one proposal from Terracon and are seeking another proposal. As of the date of this memo we have not received any additional proposals.

**Recommendation:** Authorize the Chairman, District Manager, and the District Attorney to take the following actions: (See Attached)

- Develop a contract with the lowest responsive bidder.
- Authorize the expenditure of not to exceed \$65,000 dollars.
- Authorize the Chairman to execute the contract.

Monitoring Report – Grand Oaks Phase 1 Construction

Re: Permit Number: 139022-4 Item Numbers:1381946, 1377685

Dear Mr. Harris,

The St. Johns River Water Management District is in receipt of the fall 2021 monitoring report for the areas defined as upland buffer enhancements associated with the above referenced permit. A field inspection of buffers 1-7 as shown on Figure 4, identified the following potential deficiencies.

- Several buffers are being maintained (mowed) by homeowners.
- Structures, such as bird feeders, are placed within the buffer.
- In some areas, survivorship of planted trees appears to be below the established success criteria. Replanting plan should include appropriate species and density for given site conditions.
- Cover by invasive species (*Triadica sebifera*, *Urena Lobata*, *Sesbania punicea*, and *Typha sp.*) appears to exceed 5% aerial coverage specified by the permit.
- Upland buffer signage does not appear to be in place per condition #30 of permit.

Please note that unless these deficiencies are addressed, the project may fail to meet the success criteria specified by the permit. Please provide a remedial plan and implementation time frame as to how the above bulleted items will be addressed by November 13, 2023. Please include the 2022 and 2023 monitoring reports with your next submittal.

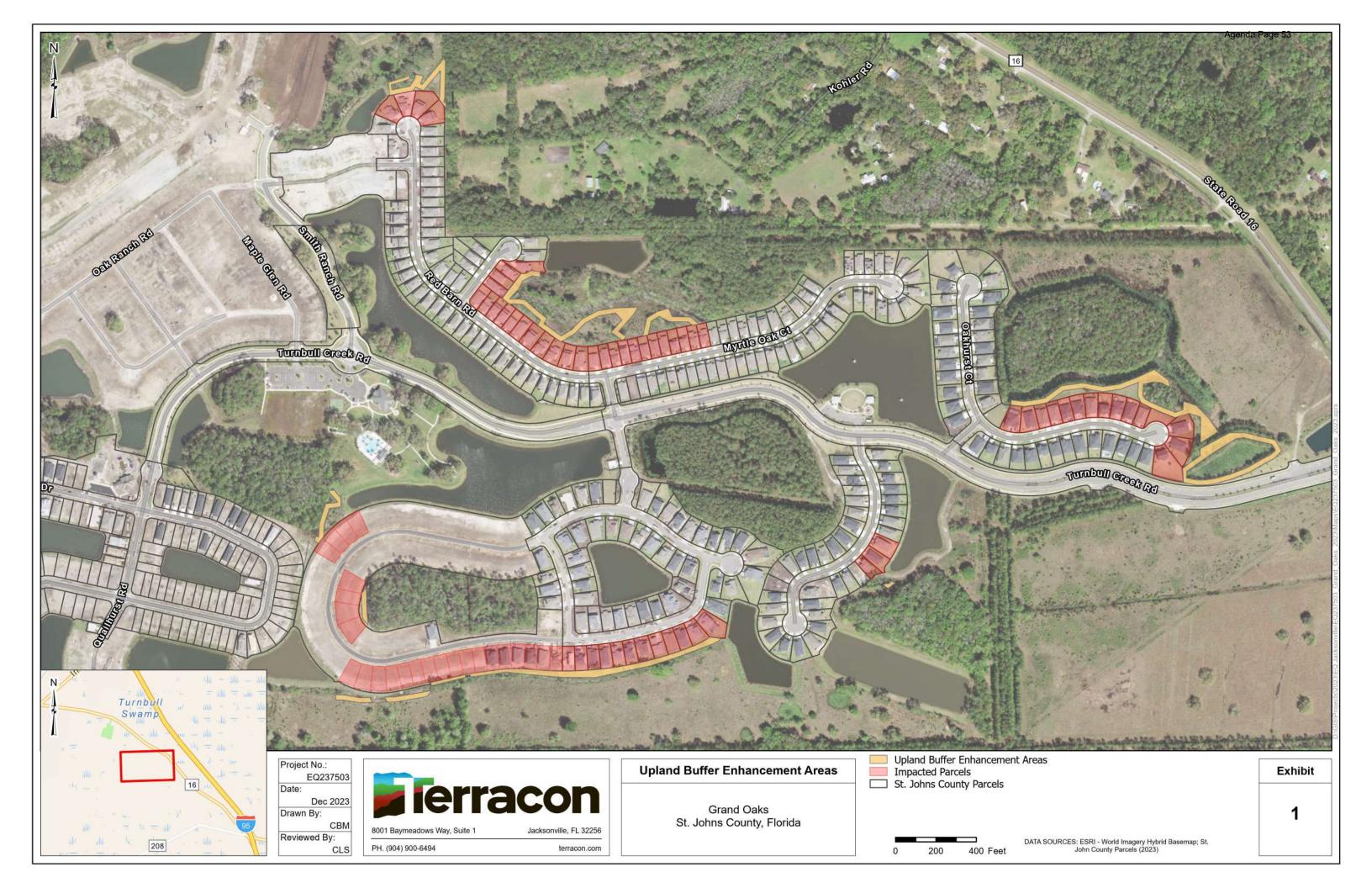

#### SUPPLEMENT TO AGREEMENT FOR SERVICES

# CHANGE TO SCOPE OF SERVICES AND FEES

This **SUPPLEMENT to AGREEMENT FOR SERVICES** to the original Agreement for Services (original Agreement dated 11/28/2023) is between Grand Oaks Community Development District ("Client") and Terracon Consultants, Inc. ("Consultant") for additional or changed Services to be provided by Consultant for Client on the Project, as described in the Agreement for Services. This Supplement is incorporated into and part of the Agreement for Services.

 Scope of Services. The scope of the additional or changed Services are described in the Scope of Services section of the Consultant's Supplemental Proposal, unless Services are otherwise described below or in Exhibit B to this Supplement (which section or exhibit are incorporated into the Supplement).

Per the St. Johns River Water Management District (SJRWMD) permit criteria, the upland buffer zones associated with Phase 1 of the Grand Oaks Residential Neighborhood are no longer meeting success criteria and are deemed as being out of compliance. In order to fulfill the approved permit criteria, Grand Oaks is required to replant the upland buffer zones, herbicide and remove invasive species, notify homeowners and landscapers of trespassing & disturbance, and install permanent signage throughout each buffer zone. Terracon is presenting Grand Oaks with the possible options to achieve the request made by SJRWMD.

Task 1. Option 1. Replanting (including bareroots), Invasive Species Removal, and Signage Installation – The upland buffer areas will be replanted back to the required density, which will consist of approximately 870 3-gallon trees, and 8,500 bareroot herbaceous species (requested by SJRWMD due to constant mowing). All invasive species will be treated with herbicide and larger species will be cut down and hauled away. Posted No Trespassing signs will be installed throughout the buffer zones. These areas will require 4 monitoring events, which includes a baseline report, followed by three annual monitoring events. This fee does not include the costs for future monitoring events.

Task 2. Option 2. Replanting (no bareroots, pending WMD approval), Invasive Species Removal, and Signage Installation – The upland buffer areas will be replanted back to the required density, which will consist of approximately 870 3-gallon trees. Terracon will request that SJRWMD allows for the delay herbaceous bareroot species planting to allow for the buffer zones to naturally regenerate. The subsequent monitoring event will determine if the areas have a successful natural recruitment, or if herbaceous planting will be required. All invasive species will be treated with herbicide and larger species will be cut down and hauled away. Posted No Trespassing signs will be installed throughout the buffer zones. These areas will require 4 monitoring events, which includes a baseline report, followed by three annual monitoring events. This fee does not include the costs for future monitoring events.

Task 3. Option 3. Permit Modification – Mitigation Credits \*\*\*PENDING CREDIT AVAILABILITY\*\*\* Terracon will consult with SJRWMD as well as with Wetland Mitigation Banks within Basin 5 to apply for a permit modification to allow the Grand Oaks Residential Development to purchase wetland credits as a form of mitigation for secondary impacts to the on-site wetlands. Under this option, no buffer zones will need to be replanted, nor will any annual monitoring events be required. However, due to the current lack of available mitigation bank credits within Basin 5, any available credits are being sold above traditional market costs. To satisfy SJRWMD mitigation requirements, the project would require approximately 0.3 credits, resulting in an approximate cost of \$58,600.00. Please note this option is ultimately dependent upon credit availability and may indefinitely delay the resolution of the compliance issue. Please note that any fees required for mitigation credits are to be paid directly by the Client.

- 2. Compensation. Client shall pay compensation for the additional or changed Services performed at the fees stated in the Supplemental Proposal unless fees are otherwise stated below or in Exhibit C to this Supplement (which section or exhibit are incorporated into the Supplement).
  - Task 2. Option 1. Replanting (including bareroots), Invasive Species Removal, and Signage Installation \$70,750.00
  - Task 2. Option 2. Replanting (no bareroots, pending WMD approval), Invasive Species Removal, and Signage Installation \$51,750.00

Task 2. Option 3. Permit Modification – Mitigation Credits - \$66,500.00 estimate. \*This fee includes the estimated cost for wetland mitigation credits (\$58,600). If this option is available, the estimated credit fee is to be paid by the client directly to the mitigation bank\*

All terms and conditions of the **Agreement for Services** shall continue in full force and effect. This Supplement is accepted and Consultant is authorized to proceed.

# **Compliance Audit Overview**

The Community Website Compliance Audit (CWCA) consists of a thorough assessment of Florida Community Development District (CDD) websites to assure that specified district information is available and fully accessible. Florida Statute Chapter 189.069 states that effective October, 2015, every CDD in the state is required to maintain a fully compliant website for reporting certain information and documents for public access.

The CWCA is a reporting system comprised of quarterly audits and an annual summary audit to meet full disclosure as required by Florida law. These audits are designed to assure that CDDs satisfy all compliance requirements stipulated in Chapter 189.069.

# **Compliance Criteria**

The CWCA focuses on the two primary areas – website accessibility as defined by U.S. federal laws, and the 16-point criteria enumerated in <u>Florida Statute Chapter</u> 189.069.



# **ADA Website Accessibility**

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines – WCAG 2.1, which is the international standard established to keep websites barrier-free and the recognized standard for ADA-compliance.



# Florida Statute Compliance

Pursuant to F.S. <u>189.069</u>, every CDD is required to maintain a dedicated website to serve as an official reporting mechanism covering, at minimum, 16 criteria. The information required to report and have fully accessible spans: establishment charter or ordinance, fiscal year audit, budget, meeting agendas and minutes and more. For a complete list of statute requirements, see page 3.

# **Audit Process**

The Community Website Compliance Audit covers all CDD web pages and linked PDFs.\* Following the <u>WCAG 2.1</u> levels A, AA, and AAA for web content accessibility, a comprehensive scan encompassing 312 tests is conducted for every page. In addition, a human inspection is conducted to assure factors such as navigation and color contrasts meet web accessibility standards. See page 4 for complete accessibility grading criteria.

In addition to full ADA-compliance, the audit includes a 16-point checklist directly corresponding with the criteria set forth in Florida Statute Chapter 189.069. See page 5 for the complete compliance criteria checklist.

\* **NOTE**: Because many CDD websites have links to PDFs that contain information required by law (meeting agendas, minutes, budgets, miscellaneous and ad hoc documents, etc.), audits include an examination of all associated PDFs. **PDF remediation** and ongoing auditing is critical to maintaining compliance.

# **Accessibility overview**

### Everyone deserves equal access.

With nearly 1-in-5 Americans having some sort of disability – visual, hearing, motor, cognitive – there are literally millions of reasons why websites should be fully accessible and compliant with all state and federal laws. Web accessibility not only keeps board members on the right side of the law, but enables the entire community to access all your web content. The very principles that drive accessible website design are also good for those without disabilities.

# The legal and right thing to do

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines, WCAG 2.1, the international standard established to keep websites barrier-free. Plain and simple, any content on your website must be accessible to everyone.



# **ADA Compliance Categories**

Most of the problems that occur on a website fall in one or several of the following categories.



#### Contrast and colors

Some people have vision disabilities that hinder picking up contrasts, and some are color blind, so there needs to be a distinguishable contrast between text and background colors. This goes for buttons, links, text on images – everything. Consideration to contrast and color choice is also important for extreme lighting conditions.

# Using semantics to format your HTML pages

When web page codes are clearly described in easy-to-understand terms, it enables broader sharing across all browsers and apps. This 'friendlier' language not only helps all the users, but developers who are striving to make content more universal on more devices.



#### Text alternatives for non-text content

Written replacements for images, audio and video should provide all the same descriptors that the non-text content conveys. Besides helping with searching, clear, concise word choice can make vivid non-text content for the disabled.

### Ability to navigate with the keyboard

Not everyone can use a mouse. Blind people with many with motor disabilities have to use a keyboard to make their way around a website. Users need to be able to interact fully with your website by navigating using the tab, arrows and return keys only. A "skip navigation" option is also required. Consider using <a href="WAI-ARIA">WAI-ARIA</a> for improved accessibility, and properly highlight the links as you use the tab key to make sections.

# Q

### Easy to navigate and find information

Finding relevant content via search and easy navigation is a universal need. Alt text, heading structure, page titles, descriptive link text (no 'click here' please) are just some ways to help everyone find what they're searching for. You must also provide multiple ways to navigate such as a search and a site map.

### **Alternate versions**

Attempts to be fully accessible sometimes fall short, and in those cases, alternate versions of key pages must be created. That is, it is sometimes not feasible (legally, technically) to modify some content. These are the 'exceptions', but still must be accommodated.



#### Feedback for users

To be fully interactive, your site needs to be able to provide an easy way for users to submit feedback on any website issues. Clarity is key for both any confirmation or error feedback that occurs while engaging the page.



### Other related requirements

### No flashing

Blinking and flashing are not only bothersome, but can be disorienting and even dangerous for many users. Seizures can even be triggered by flashing, so avoid using any flashing or flickering content.

#### **Timers**

Timed connections can create difficulties for the disabled. They may not even know a timer is in effect, it may create stress. In some cases (e.g., purchasing items), a timer is required, but for most school content, avoid using them.

#### Fly-out menus

Menus that fly out or down when an item is clicked are helpful to dig deeper into the site's content, but they need to be available via keyboard navigation, and not immediately snap back when those using a mouse move from the clickable area.

#### No pop-ups

Pop-up windows present a range of obstacles for many disabled users, so it's best to avoid using them altogether. If you must, be sure to alert the user that a pop-up is about to be launched.

# **Web Accessibility Glossary**

Assistive technology	Hardware and software for disabled people that enable them to perform tasks they otherwise would not be able to perform (eg., a screen reader)
WCAG 2.0	Evolving web design guidelines established by the W3C that specify how to accommodate web access for the disabled
504	Section of the Rehabilitation Act of 1973 that protects civil liberties and guarantees certain rights of disabled people
508	An amendment to the Rehabilitation Act that eliminates barriers in information technology for the disabled
ADA	American with Disabilities Act (1990)
Screen reader	Software technology that transforms the on-screen text into an audible voice. Includes tools for navigating/accessing web pages.
Website accessibility	Making your website fully accessible for people of all abilities
W3C	World Wide Web Consortium – the international body that develops standards for using the web
